Beginning this year, ABAM will implement a new registration and billing cycle in order to align with changes that have occurred in addiction medicine credentialing.

The first phase of the new cycle will begin mid July and end September 15, 2018. The final phase will be completed in 2019 converting to a June-June billing cycle. *The December 15 completion date for LLSA (Part 2) will remain unchanged.*
